

Pet Care Service Agreement

48 hour notice must be given for non-holiday service cancellations, or a \$50 fee will be charged. Holiday services will require a non-refundable deposit of half of the full service payment upon booking and the balance due at the start of the service. Cancellations less than 48 hours before a holiday will incur the full amount of service charge, at my discretion. I appreciate your understanding in this matter due to the high demand during the holiday season.

Such loving care to include, but not be limited to, the following: feeding and water of listed pets, scooping of cat pan, collecting mail/paper, and medications as noted on the Care Information Sheet. Owner will provide all food supplies. Rene' Downey reserves the right to purchase additional food and/or supplies for animal(s) if needed. Owner agrees to reimburse Rene' Downey for said additional food and/or supplies.

It is understood and agreed between Owner and Rene' Downey, that this agreement contemplates that Owner will be in need of Rene' Downey's services from time to time in the future. It is further understood and agreed that the obligations and convenience contained herein shall apply to each provision of service in the future without the need of entering into another agreement in writing and signed by the parties herein. A new agreement must be executed if Owner moves.

It is also hereby agreed that Rene' Downey will retain keys and any necessary access codes, to Owner's property until such time as Owner wishes the return of said keys and access codes. Keys will ONLY be returned in person to the Owner, to Owner's authorized representative.

In the event of any emergency involving the health of any animal being cared for by Rene' Downey, Owner hereby authorizes Rene' Downey to obtain such emergency veterinarian care for Owner's animal(s) as may deem necessary. Owner further authorizes Rene' Downey to incur veterinarian costs in the name of the Owner. Owner agrees to hold harmless Rene' Downey from any liability arising from such veterinary charges. As further considerations for the services rendered, Owner agrees to waive and release Rene' Downey and/or her representatives from any claim for injury, loss, and/or death of Owner's animal and from any claim for loss and/or damage to Owner's property including, but not limited to, that caused by Owner's animal. Any phone calls to the Owner referencing the care of their pet will be paid by the Owner.

For the safety and well being of your animal(s) and the security of your property, all parties agree that no other person(s), including family members, shall have access to Owner's animal(s) and/or property during the dates of service except Rene' Downey and/or her representatives. The police will be called on all intruders or suspicious acts. Persons that might be on the property will be listed on Care Information sheet prior to Owner's departure.

For first time clients I request that payment be made in full for services rendered at the time of booking services or meet and greet. For my "regular clients" I request payment on the first day of services rendered. For my "weekly mid-day clients" payment can be rendered in full at the first of the month, weekly or bi-monthly. A "Return Check Charge" of no less than \$ 35.00 will be incurred for all returned checks. I prefer payments to be made by check but can make arrangements to accept cash or online using Zelle.
